

**BYLAW #03-2002**

**A BYLAW IN THE TOWN OF LEGAL IN THE PROVINCE OF ALBERTA TO AMEND BYLAW #01-96 BEING A BYLAW TO REGULATE THE FORM, CONTENT, AND COST OF PERMITS FOR THE CONSTRUCTION, DEMOLITION, RELOCATION, ALTERATION, REPAIR, OR OCCUPANCY OF BUILDINGS.**

**WHEREAS** pursuant to the Safety Codes Act, of the revised Statutes of Alberta, provides that the local authority may enforce or regulate the form, content, and cost of permits for construction, demolition, relocation, repair, or occupancy of buildings in its respective Municipality.

**AND WHEREAS**, the local authority may make Bylaws with respect to the following subject matters:

**NOW THEREFORE** the Municipal Council of the Town of Legal in the Province of Alberta, duly assembled, hereby enacts as follows.

1. Section A, B & C of Bylaw #01-96 is hereby amended by deleting Section A, B & C in its entirety and replacing it with Schedule "A" attached.

This Bylaw shall come into force July 1<sup>st</sup>, 2002.
