Nicolas Brown, Town of Legal Library Board (7:15 PM)

Deputy Mayor Tremblay welcomed Nicolas Brown, Chair for the Town of Legal Library who discussed the request to Town Council to consider the 2022-2023 annual funding appropriation for the Legal Library Board. This is to ensure the library's eligibility for annual funding from the Government of Alberta's Public Library Grants program. For the 2022-2023 fiscal year, the Legal Library Board is requesting the following funding: \$2,500 for Annual Municipal Funding Appropriation (\$2.00 per capita) and \$7,000 for Northern Lights Library System (NLLS) Membership – Municipality Portion (\$5.23 per capita) for a total of \$9,500.00. Funding requested as per Government of Alberta guidelines, the municipality's portion of membership in a regional library system is not considered an allowable portion of a municipal library's budget. However, given that Council would typically consider it part of the library's funding, it has been included for



clarity. Attendance of current active board members is consistent and board meetings are scheduled for the last Monday of the month. Deputy Mayor thanked Nicolas Brown for the discussion.

Community Standards Bylaw #06-2022

11473 Resolution #11473 Moved by: Councillor Malott

RESOLVED that proposed Bylaw #06-2022, being a bylaw for the purpose of regulating community standards, controlling and reducing nuisances and unsightly conditions and quality of life matters within the Town of Legal, is hereby amended as follows:

- a) Section 16.10 has been added: *An Owner or Occupant of a commercial property which does not possess a valid business license issued by the Town of Legal shall not permit the parking of a Motor Vehicle, Recreational Vehicle, trailer or boat, with or without subsisting registration unless the Motor Vehicle, Recreational Vehicle trailer or boat is owned by the Owner or Occupant of the property.*
- b) Section 18.9 has been amended with the removal of "on a hard surface area" at the end of the clause: *An owner or occupant of a premises situated on a corner lot or double fronting lot may park a Recreational Vehicle or Non-Recreation Vehicle Trailer in a rear yard.*



c) Section 18.16 will be amended to read: An owner or operator of a Vehicle and Trailer or Recreational Vehicle shall not park the vehicle and trailer or recreational vehicle on a Highway for more than seventy-two (72) consecutive hours. The thirty-six hours will be replaced with seventy-two consecutive hours.

d) Schedule "A" has been amended with the addition of:

Section	Description	Specified Penalty	Second and Subsequent Offences Within One (1)Year
16.10	Parking of a Motor Vehicle, Recreational Vehicle, trailer or boat, on Commercial property	\$250	\$500
