ABMA Bilingual Signage Project

Centennial Dog Park

An update on the research that has been completed so far by administration and Public Works was provided to Council. A viable option to help reduce the disturbance at the dog park is to put privacy slats along the north fence line. Public Works has also installed a trail camera at the park to monitor the activity of the dogs using the park.
